

As a parent, you may be concerned about your child having

ADDITIONAL LEARNING NEEDS

Getting support: a **step-by-step** guide



1. Speak to your child's teacher.

If you think that your child has Additional Learning Needs (ALN) talk to your child's teacher or ALN Coordinator (ALNCo).



2. Create an Individual Development Plan (IDP) together.

If the school agrees with you that your child has ALN, the school will work with you and your child to create an IDP.



3. Discuss any concerns with the school or local authority.

If the school does not agree that your child has ALN, or you are dissatisfied with your child's IDP, discuss it with the school or local authority.



4. You can have access to an advocate.

If the local authority agrees with the school but you are still unhappy, they can point you to independent advocacy services.



5. You have a right to appeal.

All children and young people and their parents or carers have the right to appeal against decisions to the Education Tribunal of Wales (ETW).

ANGHENION DYSGU YCHWANEGOL

Derbyn cefnogaeth: **canllaw cam wrth gam**



1. Siarad gydag athro/athrawes eich plentyn.

Os ydych chi'n tybio bod gan eich plentyn Anghenion Dysgu Ychwanegol (ADY) siaradwch gydag athro neu athrawes eich plentyn neu'r Cydlynnydd ADY.



2. Creu Cynllun Datblygu Unigol (CDU) â'ch gilydd.

Os ydych chi a'r ysgol yn gytûn bod gan eich plentyn ADY, bydd yr ysgol yn gweithio gyda chi a'ch plentyn i greu CDU.



3. Trafod unrhyw bryderon gyda'r ysgol neu'r awdurdod lleol.

Os nad yw'r ysgol yn cytuno bod gan eich plentyn ADY, neu os ydych chi'n anhapus gyda chynnwys CDU eich plentyn, trafodwch hyn gyda'r ysgol neu'r awdurdod lleol.



4. Gallwch chi gael mynediad i eiriolwr.

Os yw'r awdurdod lleol yn cytuno gyda'r ysgol ac rydych chi'n anhapus o hyd, gallant eich cyfeirio at wasanaethau eiriolaeth annibynnol.



5. Mae gennych chi hawl i apelio.

Mae gan bob plentyn, person ifanc, rhiant a gofalwr yr hawl i apelio yn erbyn penderfyniadau at Dribiwnlys Addysg Cymru.
